

## ADVERTISEMENT FOR BIDS

Subject to conditions prescribed by the University of California, Irvine, sealed bids for a Lump-Sum Contract with Alternates are invited for the following project:

**SMALL CAP 2017 – CRAWFORD FIELD IRRIGATION  
PROJECT NO. 5110370 / CONTRACT NO. 9944150**

<b><u>GENERAL DESCRIPTION OF WORK:</u></b>	

1. Upgrade the UC Irvine Crawford Fields irrigation system to include installation of a new C-900 PVC 8" mainline loop around the field tied to the existing IRWD reclaimed water meter and supply line at University and Campus.
2. Install new epoxy-coated, resilient wedge gate valves, lateral lines, and sprinkler heads, new system controls, and repair damage done to the field turf during construction.
3. Portions of the existing supply mainline system are between 30 and 60 years old. Coordinate asbestos abatement and disposal with the University at all points where the new system intersects the existing pipe.
4. Coordinate with Athletics and Landscape & Grounds staff throughout to ensure all existing landscape irrigation pipes are reconnected properly.

**BIDDER QUALIFICATIONS:** The successful Contractor will be required to have the following California contractor's license (s): active at the time of submission of the Bid:

**A, GENERAL ENGINEERING CONTRACTOR or C34, PIPELINE CONTRACTOR**

Bidders will be required to submit a completed Statement of Bidder's Qualifications at the time of bid. Bidders that do not submit a completed Statement of Bidder's Qualifications or do not meet the University's requirements for relevant project experience, financial ability to complete the project, safety record and professional conduct will be eliminated.

**MANDATORY PRE-BID CONFERENCE:** The Pre-Bid Conference and Job Walk will be conducted on **Tuesday, October 17, 2017** at **10:00 AM** at the UCI Design & Construction Services, Wright Conference Room, 101 Academy, Suite 200, Irvine, CA 92697. Contractors arriving after **10:00 AM** will not be eligible to participate in the bid process as a General Contractor. Only bidders who participate in both the pre-bid conference and the job walk in their entirety will be allowed to bid on the Project as General Contractors.

**BID SUBMITTAL REQUIREMENTS:** Sealed bids shall be submitted to UCI Design & Construction Services, 101 Academy, Suite 200 by **2:00 PM** on **Tuesday, October 31, 2017**.

The successful Contractor and its Subcontractors shall be required to follow the nondiscrimination requirements set for in the Bidding Documents and to pay prevailing wage rates at location of work.

Every effort will be made to ensure that all persons have equal access to contracts and other business opportunities with the University within the limits imposed by law or University policy. Each Bidder may be required to show evidence of its equal employment opportunity policy. The successful Bidder and its subcontractors will be required to follow the nondiscrimination requirements set forth in the Bidding Documents and to pay prevailing wage at the location of the work.

No contractor or subcontractor may be listed on a bid for this project (submitted on or after March 1, 2015) unless registered with the Department of Industrial Relations pursuant to Labor Code section 1725.5 [with limited exceptions from this requirement for bid purposes only under Labor Code section 1771.1(a)].

No contractor or subcontractor may be awarded any portion of this project (awarded on or after April 1, 2015) unless registered with the Department of Industrial Relations pursuant to Labor Code section 1725.5.

This project is subject to compliance monitoring and enforcement by the Department of Industrial Relations.

The successful Bidder shall pay all persons providing services and/or any labor on site, including any University location, no less than the UC Fair Wage (defined as \$13 per hour as of 10/1/15, \$14 per hour as of 10/1/16, and \$15 per hour as of 10/1/17) and shall comply with all applicable federal, state and local working condition requirements.
